# Key findings

- Engaging diverse community actors and stakeholders in a meaningful way is possible only if tailor-made approaches are used to contact and interact with them.
- For cases targeting vulnerable actors, creating a safe space is a crucial requirement to start the engagement.
- The motivation of the individuals depends on how well the learning objectives align with their aspiration.
- Selecting a suitable method (i.e. pairing the most suitable intervention to every case) is crucial.
- Stakeholder mapping helps build diverse learning communities, inclusive of civil society, business, and policy sectors.
- Intersectionality guides the selection of learning community members with varied experiences and backgrounds.

## Work process for supporting and mentoring cases

The process aimed to help cases establish diverse Learning Communities and Stakeholder Boards in different localities and sectors, as well as co-define the learning objectives of these cases.

While the general question is the same across all cases (i.e., how to foster behavioural and institutional change to safeguard and prioritise biodiversity in decision-making), the specific foci of the cases reflect the needs of local communities and main stakeholders, as well as the contextual specificities. Crucially, we had to ensure the co-working process within each case.

Learning communities – linking to the intensive cases – help co-design the research process and reflect on the usefulness of the tested methods together with local stakeholders (e.g. urban youth, minority communities).

The sector-based extensive cases are supported by stakeholder boards (including experts and stakeholders from the given sectors), which are regularly consulted to ask for their feedback and benefit from their outreach and upscaling potential.

Ensuring the diversity of people invited to Learning Communities and Stakeholder Boards is a key to cross boundaries between academia and society, and to build bridges between economic, policy and civil society actors. Therefore, we steered the engagement capacity of the cases to build up diverse communities.

The Task leaders guided and supported the cases to carry out their own engagement process, coordinated exchange and co-learning between the cases, and carried out the analysis of the reports prepared by the cases. Get familiar with these cutting-edge cases by downloading the full document.

## Build new perspectives

With several methods and field work, PLANET4B successfully helped to build new relationships among stakeholders and in some cases helped form bottom-up communities of practice. This provided opportunities for interactions and co-learning to start system wide transformations.

With the support of the PLANET4B project, the cases can make important steps towards the appreciation and operationalisation of the diverse values social actors attach to nature. With these lenses, cases can impact social and policy decisionmaking towards biodiversity prioritisation.

On top of that, new voices could be channelled into professional and public dialogues around biodiversity.
